Goal

Eligibility criteria

- Owning in whole or in part, with a minimum of 20% of the shares of the farm;
- Be between 18 and 40 years old;
- Hold a degree in agriculture or equivalent training;
- Present a project that will increase productivity of farmland;
- Maximum of 20 eligible farms per year, from October 1st to September 30th of each year;
- The program must be completed in collaboration with your Synagri representative;
- Duration of the commitment: 3 years.

Offered services

Up to a maximum of \$ 10,000 spread over 3 years in available credit for each farm admitted to the program. The credits will be allocated according to the following categories, at the choice of the participant, in collaboration with your Synagri representative:

1. Productivity and agronomic data management;
 2. High performance product management;
 3. Training management (mandatory), through the Synagri Academy (Does not affect the \$ 10,000 credit over 3 years).
